Description of the PPE:

Glove with five fingers, made without seams in pink colour. The glove covers the hand from the tips of the fingers, including the interdigital area, to the palm and back, and finishes in the opening area. The length of the glove allows it to cover part of the arm. The material creates a relief like a net in the palm and the internal face of the fingers. In the opening area there is a floral relief drawing, this is included in the size in a relief mark. The internal face of the gloves is a non-woven in white color. A pair of gloves, sized 8-M can weigh approximately 80,70 grams.

The component materials of the PPE are:

- PVC coating in pink colour.
- Flockline cotton in white color.

The PPE may carry the following variants:

- The gloves can be in the next colours: yellow, pink, light blue, dark blue and blue.

It shall be the manufacturer's sole responsibility to furnish specific information pertaining to this certificate and the tested levels of protection.
